



# **OHSU Addiction Medicine ECHO Certificate Program**

Clinicians and health professionals practicing in Oregon are invited to participate in the OHSU Addiction Medicine ECHO Certificate Program. ECHO is a tele-mentoring program that uses videoconferencing technology to combine brief didactic presentations with interactive and practical case presentations from participants.

The goal of the OHSU Addiction Medicine ECHO Certificate Program is to foster leadership and expertise in the diagnosis, treatment, and systems development for the effective care of patients with substance use disorders (SUD) and chronic pain across a variety of clinical settings.

## **Benefits of participation include:**

- Greater knowledge, skills and confidence to screen, diagnose and treat patients with SUD and chronic pain
- Networking and relationship building with specialists, clinicians, and healthcare professionals throughout Oregon who provide care to patients with SUD and chronic pain
- No cost CME and Maintenance of Certification part 2 credits for internal medicine and family medicine physicians are awarded based on participation and attendance

# **Frequently Asked Questions**

 Am I required to complete the complete the certificate in a defined time frame? No, participants can complete the certificate over time. What qualifies as active participation in the program?
 Active participation in the program is defined as focused

- attention, asking questions, and participating in discussions during the ECHO sessions. Active participation also includes participating in program evaluation activities, which could include preprogram, post-program and per-session surveys; focus groups; or structured interviews. Volunteering to present at least one case per program is strongly encouraged.
- 3. What happens if I do not complete the certificate? You will still receive the CME and MOC credits you earned based on participation in the sessions.
- 4. How do I sign up for the certificate program? ECHO participants who are interested in completing the certificate program will be asked to indicate their intention to complete the certificate program during the ECHO registration process.
